# Deed of Foundation of the Hungarian Intellectual Property Office

(consolidated text)

By virtue of Article 8/A of Act CXCV of 2011 on Public Finances, I hereby issue the Deed of Foundation of the Hungarian Intellectual Property Office (hereinafter "Deed of Foundation") as follows:

### 1. Name, seat and premises of the budgetary organ:

# 4. Tasks of the budgetary organ

- 4.1. Public duties of the budgetary organisation: The Hungarian Intellectual Property Office is responsible for the protection of intellectual property, its public duties are laid down in Article 115/G of Act XXXIII of 1995 on the Protection of Inventions by Patents as follows:
- a) conducting official examinations and procedures in the field of industrial property;
- b) performance of certain tasks in connection with copyright and rights related to copyright;
- c) central governmental information and documentation activities in the field of intellectual property;

- d) participation in the preparation of intellectual property legislation;
- e) preparation and implementation of the Government's strategy for the protection of intellectual property, initiation and execution of governmental measures required for this purpose;
- f) performance of professional tasks of international and European co-operation in the field of intellectual property protection;
- g) performance of official and expert tasks relating to the qualification of research and development activity.

### 5. Organisation and operation of the budgetary organ

Other employer's rights over the President shall be exercised by the minister supervising the Office.
